Dear Parents

Nearly after eighteen months, the school will finally open its gates for the students. The Government of India (MHRD and Directorate General of Health Services) has issued SOP for partial reopening of schools for students of classes IX to XII. Although Directorate of Education has permitted to resume normal school for classes IX to XII, yet we plan to initially begin with classes XI and XII only, that too in a wise phased manner following the generic precautionary measures outlined by the authorities to ensure total safety of both students and staff.

As per plan, classes will be called in small batches of limited students from Monday, 6 September till 16 September 2021 prior to preparatory vacation from 17 September for 1 Term Pre Board Examination for class XII and final Term 1 of class XI. Schedule for classes after exams will be given later. The classes will facilitate completion of syllabuses, revision work, lab work, practical work, ASL, assignments, project work of all subjects besides face to face interaction with teachers, all very vital in the holistic preparation in any class.

Please note the following guidelines in this regard

1- Every class will be divided into two segments - A and B and each of these segments will come to school on alternate days.

2- Students of class XII will enter between 7.50 am to 8.25 am from gate no.1 for rooms in building no.1 and students of class XI will enter from gate no.3 for building no.2.

3- The standard protocols and the Covid-appropriate behaviour will be strictly maintained.

4- Wearing masks, social distancing, restricted movement will be strictly adhered to.

5- Students must be in proper school uniform and carry their own lunch and water bottles.

6- The timetable will be shared by the concerned class teacher.

7- No transport facility will be provided. Students will commute on their own.

8- The dispersal of students will be between 1.30 pm to 2 pm.

9- Parents are strictly advised not to send their ward in case she/he is unwell or displays symptoms of any infection.

10- No virtual periods will be taken for classes XI and XII in this duration.

11- ASL, practicals or projects done offline in this period may be marked for final internal assessment evaluation.

I seek your valuable consent in the execution of the classes which shall be planned meticulously ensuring complete safety precautions. Kindly note that students will have to strictly adhere to the guidelines issued by the school for example wearing of masks, social distancing etc. No transport facility will be provided and students will commute on their own.

You are requested to send your confirmation immediately to allow us to proceed with the preparations.
